Project Topic/Title:

Eco-Sense Training Presentation on Energy Star v 3.1

- This will be an ILT presentation with the effectiveness determined by the performance outcome.

What do you see as the problem you are hoping to solve with this training?

The client has noticed that homes that his builder clients have built to pass the Energy Star v 3.0 standards are not all passing the new, more stringent standards (Energy Star v. 3.1).

What are the goals of this training/course?

The client would like to provide training to builders so that more homes can pass the Energy Star v 3.1 inspections.

Objectives:

- Builders will:
 - Understand the key differences between v3.0 and v3.1
 - Understand the key areas where homes are having trouble passing v3.1
 - Gain new strategies to ensure homes meet the new, more stringent v3.1 standards
 - Return to a success rate of 90%+ homes passing Energy Star inspections

How will the learner benefit from this training/course?

The learner will benefit by gaining new strategies for getting homes to pass the Energy Star v3.1 inspections, resulting in higher pass rates for the homes they are building.

How will the organization/company benefit from this training/course?

Eco-Sense will benefit in the long run b/c if builders cannot get their homes to pass the inspections then they may stop contracting Eco-Sense to do the inspections. If builders can pass inspections, they will continue to do business with Eco-Sense.

Who are the learners?

The learners are builders and contractors.

What should the learners be able to do following this training?

The learners should be aware of the changes to the Energy Star rating system and should be able to use the recommended strategies when building homes so that the homes will pass the inspections.

How will you know if the goals and learning objectives have been achieved?

If builders apply the strategies, the inspection pass rate for their homes should increase.

The client does not want a formal assessment.

Recommendations (To be shared with client via email after Needs Assessment Meeting):

Option 1:

- **ILT Slide Presentation:**
 - Create simple and modern template design using branding/colors from website
 - Modify content from client provided presentation to support learner engagement and retention of information
 - Include text and image animation
 - Add icons where applicable
 - Recreate tables to fit branding colors
- **Job Aid:**
 - Create pdf Job Aid for Compliance Strategies that builders can access on their phones as a reference tool

Option 2:

- **ILT Slide Presentation:**
 - Includes all Option 1 features, plus:
 - Add gamified learning checkpoints to keep learners engaged during the training (Kahoot)
- **Job Aid:**
 - Same as Option 1
- **Instructional Video:**
 - Create and instructional video using the slide deck. This could be shared with new builders/customers to streamline the training process and ensure a high success rate from the beginning when working with new builder clients.
 - Write a script/narration for the video - This will require more detailed input from the client/SME.
 - Final deadline will need to be pushed out by 2 weeks.
